I also agree that if my account is sent to a collection agency due to my failure to pay that I will be liable for all collection agency fees and the outstanding amount due the DISTRICT.

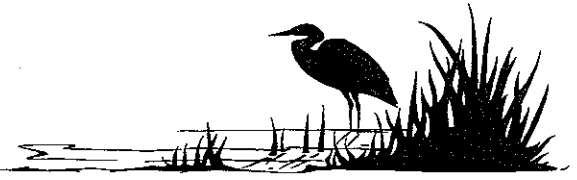
